ADDITIONAL CHARGES

The fee charged includes all preparation, and reporting time. The cost of facilities, catering if requested, or parking will be an additional charge. For mediations west of Burlington, north of Barrie, and east of Oshawa, a travel charge of \$100.00 per hour will apply. For travel outside of Toronto, a kilometer charge will be applied.

CANCELLATION FEES

ADDITIONAL CHARGES

The fee charged includes all preparation and reporting time. The cost of facilities, catering if requested, or parking will be an additional charge.

CANCELLATION FEES

Cancellation fees are in accordance with Rules 75.1.08 and 75.1.09 of the Rules of Civil Procedure and O. Reg. 43/05, s. 5 (3).

Most significantly, if the mediator cancels a session because a party fails to attend within the first 30 minutes of the session, the party who fails to attend shall pay any cancellation fees. Also, if two (2) or more parties fail to attend, they shall pay the cancellation fees in equal shares.
